The following questions have been received regarding RFP 122803, Band Uniforms – West Florida High School. Those questions and answers are listed below, along with other additional information.

Question 1: In the styling specs under "coat" it calls for a Dacron fabric, however the numbers provided (6248) is a 100% polyester fabric. Need to know if you want a dac/wool coat or a polyester? There is a major difference between the two, price wise, with the Dacron fabric being more expensive. Please give some clarification on the coat and fabric.

Answer: The school wants a machine washable uniform - Polyester 14.0 oz. Male and female patterns, with adjust-a-length snap cuffs. Please see the full RFP for additional information. All other coat specifications remain the same.

Question 2: The plume calls for a "short" plume. There are two types for an aussie hat, one which sits on the brim and wraps around it while the other sticks in the side and protrudes at a 45 degree angle. Which one does he want?

Answer: The black aussie hat with a red band with a white marabou fan plume.

In addition to the above, please add the following adjustments to the Bibber Specifications

Adjust-a-length snap cuffs.

Shoulder straps to be nylon/webbed with nickel plated brass sliders.

Gusset under the arm of heavy duty spandex.

Machine Washable.

All other specifications of the bibber remain unchanged.
