DESCRIPTION OF PURCHASE:

Band uniforms for the Northview High School marching band. The solicitation is for: seventy (70) bibber trousers, seventy (70) marching coats, seventy (70) capes, seventy (70) vanguard helmets, seventy (70) helmet plumes, sixty (60) regular gauntlets, ten (10) percussion gauntlets, and one (1) uniform management software program. The total price is estimated at \$28,055.70.

Uniform samples were examined by an Evaluation Committee consisting of two (2) Northview High School staff members (the Band Director, and the Principal), a seamstress, and one (1) Purchasing Agents who was not a voting member of the committee. The vendor/uniform was rated by: Responsiveness to RFP (Up to 10 Points), Cost of the Garment (Up to 40 Points), Quality of the Garment (Up to 30 Points), References (Up to 10 Points), and Delivery Time (Up to 10 Points). Award to the bidder ranked highest by the Evaluation Committee.
