#### I. INTRODUCTION

The purpose of this Request For Proposal (RFP) is to solicit sealed proposals for the direct delivery of frozen breakfast and lunch entrees to the school cafeterias in the Escambia County School District (ECSD). The initial term shall be effective from August 1, 2018 through April 30, 2019 with two (2) oneyear renewal periods upon mutual consent of both parties and School Board approval. The initial one (1) year renewal period shall be in effect for the period of May 1, 2019 through April 30, 2020. Either party can cancel the agreement without reason at the end of each contract year. **Cancellation must** be in writing and received ninety (90) calendar days prior to the end of each contract year. The awarded Responder must be able to provide and deliver a minimum of 85% of all the products listed in Section VII – Pricing and Specifications. All items in bold type and marked with an asterisk (\*) must have a price offer for your proposal to be considered. The quantities listed herein are estimates based on prior and projected usage. The District will make every attempt to adhere as closely as possible to the estimated quantities. However, the District reserves the right to reduce the quantities and/or purchase additional quantities at the contract price at any time during the agreement.

If offering a brand and/or product OTHER THAN ONE OF THE PREAPPROVED BRANDS LISTED, make a notation in the comments section for that item. If you offer a product that is not preapproved in this solicitation, you must send a sample for review by <u>Friday, March 16, 2018, 12:00 PM, CST. Failure to send a full case quantity sample size in its original packaging and the required documentation when offering an alternate product will result in your bid being determined "non-responsive" for that item. Unmarked boxes or bags containing loose samples are not acceptable. Samples should be clearly labeled "<u>SAMPLE FOR RFP NUMBER#180902."</u> If you plan to send samples, the required form and instructions will be posted on the Purchasing website at <u>http://ecsd-fl.schoolloop.com/purchasing/bids</u>. This form must be completed prior to samples being sent. All food samples should be delivered to the Escambia County School District Central Warehouse, 51 East Texar Drive, Pensacola, FL 32503. QUESTIONS: Due to time constraints, it is recommended that vendors send questions regarding this RFP in a manner that can be tracked (email, certified mail, or overnight courier); email is preferred. Deadline for questions will be **Friday, March 9, 2018, 12:00 p.m.**, Central Standard Time. Changes in the specifications contained in this RFP will be made by Addenda. Any Addenda issued concerning this RFP will be posted on the Purchasing Department's web pages. <u>PRIOR TO SUBMITTING A PROPOSAL</u>, it shall be the sole responsibility of each Responder to contact the Purchasing Agent or visit the Purchasing Department's Web pages to determine if any Addenda has been issued and to obtain such Addendum. Any addendum and answers to any questions received concerning this RFP will be posted by the close of business on **Wednesday, March 14, 2018**. For the Escambia County School District (ECSD) to ensure equal treatment of all participating vendors, the above named individual is ECSD's only designated representative for this RFP. Vendors are expected to utilize this representative for ALL Information regarding this RFP. Vendors who contact any other District employee regarding the subject of this RFP are subject to disqualification from participating in this solicitation.

#### **II. GENERAL TERMS AND CONDITIONS.**

NOTE: The terms "Responder, Vendor, or Contractor" as used within this Request For Proposal (RFP) refers to the person, company or organization responding to this RFP. The Responder/Vendor/Contractor is responsible for understanding and complying with the terms and conditions herein.

- A. GENERAL: Upon an RFP award, the terms and conditions of this RFP or any portion thereof, may upon mutual agreement of the parties be extended for an additional term(s) or for additional quantities (all original terms and conditions will remain in effect). Subject to the mutual consent of the parties, the pricing, terms and conditions of this RFP, for the products or services specified herein, may be extended to other municipal, city or county government agencies, school boards, community or junior colleges, or state universities within the State of Florida.
- B. RFP OPENING AND FORM: Proposal openings will be public on the date and time specified on the Proposal Acknowledgement form. All proposals received after the time indicated will be rejected as non-responsive and retained by the District. Proposals by email, fax, telegram, or verbally by telephone or in person will not be accepted. <u>The public opening will acknowledge receipt of the Proposals only; details concerning pricing or the offering will not be announced. All proposals submitted shall become public record upon an announcement of a recommended award or thirty (30) days after the opening date whichever occurs first. To protect any confidential information contained in their Proposal, companies must invoke the exemptions to disclosure provided by law in response to the RFP, and must identify the data and other material to be protected, and must state the reasons why such exclusion from public disclosure is necessary.</u>
- C. WARRANTY: All goods and services furnished by the Responder, relating to and pursuant to this RFP will be warranted to meet or exceed the Specifications contained herein. In the event of breach, the Responder will take all necessary action, at Responder's expense, to correct such breach in the most expeditious manner possible.
- D. **PRICING:** All pricing submitted will include all packaging, handling, shipping charges, and delivery to any point within Escambia County, Florida to a secure area or inside delivery. The School Board is exempt and does not pay Federal Excise and State of Florida Sales taxes.
- E. **TERMS OF PAYMENT / INVOICING:** The normal terms of payment will be Net 30 Days from receipt and acceptance of goods or services and Responder's invoice. Itemized invoices, each bearing the Purchase Order Number must be mailed on the day of shipment. Invoicing subject to cash discounts will be mailed on the day that they are dated.
- F. TRANSPORTATION AND TITLE: (1) Title to the goods will pass to the School District upon receipt and acceptance at the destination indicated herein. Until acceptance, the Responder retains the sole insurable interest in the goods. (2) The shipper will prepay all transportation charges. The School District will not accept collect freight charges. (3) No premium carriers will be used for the School District's account without prior written consent of the Director of Purchasing.
- G. **PACKING:** All shipments will include an itemized list of each package's content, and reference the School District's Purchase Order Number. No charges will be allowed for cartage or packing unless agreed upon by the School District prior to shipment.
- H. INSPECTIONS AND TESTING: The School District will have the right to expedite, inspect and test any of the goods or work covered by this RFP. All goods or services are subject to the School District's inspection and approval upon arrival or completion. If rejected, they will be held for disposal at the Responder's risk. Such inspection, or the waiver thereof, however, will not relieve the Responder from full responsibility for furnishing goods or work conforming to the requirements of this RFP or the RFP Specifications, and will not prejudice any claim, right, or privilege the School District may have because of the use of defective or unsatisfactory goods or work.

- I. STOP WORK ORDER: The School District may at any time by written notice to the Responder stop all or any part of the work for this RFP award. Upon receiving such notice, the Responder will take all reasonable steps to minimize additional costs during the period of work stoppage. The School District may subsequently either cancel the stop work order resulting in an equitable adjustment in the delivery schedule and/or the price, or terminate the work in accordance with the provisions of the RFP terms and conditions.
- J. INSURANCE AND INDEMNIFICATION: The Responder agrees to indemnify and save harmless the School District, its officers, agents and employees from and against any and all claims and liabilities (including expenses) for injury or death of persons or damage to any property which may result, in whole or in part, from any act or omission on the part of the Responder, its agents, employees, or representatives, or are arising from any Responder furnished goods or services, except to the extent that such damage is due solely and directly to the negligence of the School District. The Responder will carry comprehensive general liability insurance, including contractual and product liability coverage, with minimum limits acceptable to the School District. The Responder will, at the request of the School District, supply certificates evidencing such coverage.
- K. RISK OF LOSS: The Responder assumes the following risks: (1) all risks of loss or damage to all goods, work in process, materials and equipment until the delivery thereof as herein provided; (2) all risks of loss or damage to third persons and their property until delivery of all goods as herein provided; (3) all risks of loss or damage to any property received by the Responder or held by the Responder or its suppliers for the account of the School District, until such property has been delivered to the School District; (4) all risks of loss or damage to any of the goods or part thereof rejected by the School District, from the time of shipment thereof to Responder until redelivery thereof to the School District.
- L. LAWS AND REGULATIONS: Responders will comply with all applicable Federal, State and Local laws, statutes and ordinances including, but not limited to the rules, regulations and standards of the Occupational Safety and Health Act of 1970, the Federal Contract Work Hours and Safety Standards Act, and the rules and regulations promulgated under these Acts. Responders agree not to discriminate against any employee or applicant for employment because of race, sex, religion, color, age or national origin.

All agreements as a result of an award hereto and all extensions and modifications thereto and all questions relating to its validity, interpretation, performance or enforcement shall be governed and construed in conformance to the laws of the State of Florida. The parties agree that jurisdiction for the resolution of any legal issues arising out of this agreement will be solely with the Circuit Courts of Escambia County, Florida. The parties hereby waive venue in any other forum.

- M. PUBLIC ENTITY CRIMES: A Responder, person, or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Florida State Statute, Section 287.017, for CATEGORY TWO for a period of 36 months from the date of being placed on the convicted vendor list.
- N. **PATENTS:** Responders agree to indemnify and save harmless the School District, its officers, employees, agents, or representatives using the goods specified herein from any loss, damage or injury arising out of a claim or suit at law or equity for actual or alleged infringement of letters of patent by reason of the buying, selling or using the goods supplied under this bid, and will assume the defense of any and all suits and will pay all costs and expenses thereto.
- O. **CONFLICT OF INTEREST:** The award hereunder is subject to the provisions of Chapter 112 Florida Statutes. All Responders must disclose the name of any company owner, officer, director or agent

who is an employee of the School District and/or is an employee of the School District and owns, directly or indirectly, an interest of five percent or more of the company.

- P. TERMINATION: DEFAULT. The School District may terminate all or any part of a subsequent award by giving notice of default to Responder, if Responder: (1) refuses or fails to deliver the goods or services within the time specified; (2) fails to comply with any of the provisions of this RFP or so fails to make progress as to endanger performances, hereunder, or; (3) becomes insolvent or subject to proceedings under any law relating to bankruptcy, insolvency, or relief of debtors. In the event of termination for default, the School District's liability will be limited to the payment for goods and services delivered and accepted as of the date of termination. CONVENIENCE. The School District may terminate for its convenience at any time, in whole or in part any subsequent award. In which event of termination, and (2) costs incurred by Responder for unfinished goods, which are specifically manufactured for the School District and which are not standard products of the Responder, as of the date of termination, and a reasonable profit thereon. In no event is the School District responsible for loss of anticipated profit nor will reimbursement exceed the RFP value.
- Q. DRUG-FREE WORKPLACE: Whenever two or more RFPs are equal with respect to price, quality, and service, an RFP received from a business that certifies that it has implemented a drug-free workplace program as defined by Section 287.087 Florida Statutes, will be given preference in the award process.
- R. PERFORMANCE: In an effort to reduce the cost of doing business with the School District, and unless indicated elsewhere, no bid or performance bond is required. However, upon award and subsequent default by Responder, the School District reserves the right to pursue any or all of the following remedies: (1) to accept the next lowest available RFP price or to purchase materials or services on the open market, and to charge the original awardees for the difference in cost via a deduction to any outstanding or future obligations; (2) the Responder in default will be prohibited from activity for a period of time determined by the severity of the default, but not exceeding two years; (3) any other remedy available to the School District in tort or law.
- S. **AUDIT AND INSPECTION:** The District or its representative reserves the right to inspect and/or audit all the Responder's documents and records as they pertain to the products and services delivered under this agreement. Such rights will be exercised with notice to the Responder to determine compliance with and performance of the terms, conditions and specifications on all matters, rights and duties, and obligations established by this agreement. Documents/records in any form shall be open to the District's representative and may include but are not limited to all correspondence, ordering, payment, inspection and receiving records, and contracts or sub-contracts that directly or indirectly pertain to the transactions between the District and the Responder.
- T. SAMPLES AND BRAND NAMES: BRAND NAMES. Specifications referencing specific brand names and models are used to reflect the kind and type of quality in materials and workmanship, and the corresponding level of performance the School District expects to receive as a minimum. Responders offering equivalents or superior products to the brand/model referenced will: (1) reference on the RFP in the space provided the manufacturer's name, brand name, model and/or part number; (2) next to the price Responder will indicate "ALT" to reflect an alternate offering; (3) where no sample is provided with the RFP, Responders will enclose sufficient technical specification sheets and literature to enable the School District to reach a preliminary evaluation; (4) the School District may request and Responder agrees to submit a sample or to provide its product on-trial or demonstration, whichever the School District may deem appropriate, at no charge to the District; (5) the School District reserves the right to determine the acceptability of any alternatives offered. SAMPLES. Any sample requested by this RFP or to be provided at the Responder's option, should be forwarded under separate cover to the attention of the Purchasing Office of the School District. The package or envelope will reference the RFP Number, RFP Title, and RFP Item Number and clearly marked "Samples". All samples will be provided free of charge, including transportation

charges. Responders are responsible for notifying and making arrangements for pick up from the School District if a return of samples is expected. All samples unclaimed for thirty (30) days will be disposed of at the discretion of the School District.

- U. **EVALUATION CRITERIA:** Primary factors used to decide the award hereunder will be price, quality, availability, and responsiveness. Other factors that may be used in the evaluation of this RFP will be: (1) administrative costs incurred by the School District in association with the discharge of any subsequent award; (2) alternative payment terms; (3) Responder's past performance. The School District reserves the right to evaluate by lot, by partial lot, or by item, and to accept or reject any proposal in its entirety or in part, and to waive minor irregularities if the proposal is otherwise valid. In the event of a price extension error, the unit price will be accepted as correct. The School District has sole discretion in determining testing and evaluation methods. The School District may consider in conjunction to any award hereunder, those products, services and, prices available to them through contracts from state, federal, and local government agencies or other school districts within the State of Florida.
- V. CLARIFICATIONS AND INTERPRETATIONS: The School District reserves the right to allow for clarification of questionable entries, and for the Responder to withdraw items with obvious mistakes. Any questions concerning terms, conditions or specifications will be directed to the designated Purchasing Agent referenced on the RFP Acknowledgement. Any ambiguities or inconsistencies shall be brought to the attention of the designated Purchasing Agent in writing at least seven workdays prior to the opening date of the proposals. Failure to do so, on the part of the bidder will constitute an acceptance by the Responder of consequent decision. An addendum to the RFP shall be issued and posted for those interpretations that may affect the eventual outcome of this bid. It is the Responder's responsibility to assure the receipt of all addendum issued. No person is authorized to give oral interpretations of, or make oral changes to the RFP. Therefore oral statements given before the RFP opening date will not be binding. The School District will consider no interpretations binding unless provided for by issuance of an addendum. Addenda will be posted to the School District's Purchasing website address at <a href="http://eccsd-fl.schoolloop.com">http://eccsd-fl.schoolloop.com</a> at least five workdays prior to the opening date. The Responder shall acknowledge receipt of all addenda by signing and enclosing said addenda with their proposal.
- W. RFP TABULATIONS, RECOMMENDATIONS, AND PROTEST: RFP tabulations with award recommendations are posted for 72 hours in the Purchasing Office and are also posted to the School District's Purchasing website address at http://ecsd-fl.schoolloop.com. Failure to file a protest within the time prescribed in Section 120.57(3) Florida State Statutes will constitute a waiver of proceedings under Chapter 120, Florida State Statutes and School Board Rules. RFP tabulations, recommendations or notices will not be automatically mailed.
- X. **CONTACT:** All questions for additional information regarding this RFP **must be directed to the designated Purchasing Agent noted on page one.** Prospective Responders shall not contact any member of the Escambia County School Board, Superintendent, or staff regarding this bid prior to posting of the final tabulation and award recommendation on the website and in the Purchasing Office. Any such contact shall be cause for rejection of your proposal.
- Y. **PROPOSAL PREPARATION COSTS:** Neither the School District nor its representatives shall be liable for any expenses incurred in connection with the preparation of a response to this proposal.
- Z. AGREEMENT FORM: All subsequent agreements as a result of an award hereunder, shall incorporate all terms, conditions and specifications contained herein, and in response hereto, unless mutually amended in writing.
- AA. **ADDITIONAL TERMS AND CONDITIONS:** The School District reserves the right to reject offers containing terms and/or conditions contradictory to those requested in this RFP.

- BB. **MODIFICATIONS:** Changes to terms and conditions must be in writing and by mutual consent of both parties and School Board approval, if needed.
- CC. **ALTERNATE OFFER:** The District shall have sole discretion in accepting or rejecting any alternate product offered.
- DD. ALTERNATE PRODUCTS: The District pre-approves products prior to the proposal evaluation. Offering any product not listed on the approved list at the time of RFP posting is an alternate offer. Responders may offer an equal alternate to the items approved. An alternate product will only be accepted if a sample is provided to the District in the time and manner listed in Section I, Introduction, page two (2) of this RFP. The District shall have sole discretion in accepting or rejecting submitted alternate products. If approved, the alternate product offered for that item will be added to the approved product list and will be accepted for potential award on this RFP. Request should be made to the Purchasing Agent listed on page one (1) and page two (2) of this document.
- **III. SPECIAL CONDITIONS** These "SPECIAL CONDITIONS" are in addition to or supplement Section II GENERAL TERMS AND CONDITIONS. In the event of a conflict these SPECIAL CONDITIONS shall have precedence.
  - A. DOCUMENTATION AND REQUIRED ENCLOSURES: All documents listed below must be returned in their entirety. Failure to return all pages (entire document) or any of the items listed below may result in your proposal not being accepted.
    - 1. **DRUG FREE WORKPLACE:** While it is not required, this form (Attachment A) will be a determining factor in evaluating an award between two (2) offers equal in price, quality, and service.
    - 2. Department of Agriculture, Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion: This form (Attachment B) must be signed and returned with the proposal. Failure to return this form will result in the proposal not being accepted.
    - 3. The entire RFP document (pages 1 102). The signature on the first page must be an <u>original</u>, <u>manual</u> signature no fax or email documents will be accepted. All certifications in this solicitation requiring vendor information and/or signature must be completed and the signature must be an original, manual signature. In the event that the Responder makes an error on entering any information and enters a correction, the Responder must initial the change(s). Any proposal submitted with strike over or white out corrections that are not initialed will be rejected as a non-responsive proposal.
    - 4. <u>Return your original proposal and one (1) copy.</u> The copy should be a photocopy of your original proposal and there should be no differences in the RFP document or attached enclosures. Any differences or failure to include RFP attachments in both sets may cause your proposal to be rejected. Please mark copy "COPY". RFP documents may be printed double-sided with left margin, book-style binding.
    - 5. Copy of Responder's current business license.
    - If not currently doing business with the Escambia County School District (ECSD), three (3) commercial clients or other School Districts similar to ECSD must be submitted. If doing business with ECSD, the School District may be used as one of your references. See attached Form Number P002 Attachment C.
    - 7. Vendor's Value Added Service Proposal: This should include, but not be limited to, information regarding your order entry technical capabilities, marketing/customer service abilities, turnaround time, and resolution of delivery/ordering errors.

- 8. Product specification sheets or certifications must be attached if requested for an item in the Specifications and Pricing Section and/or if offering alternate items. These sheets are still requested even if they were already provided with your sample product(s).
- 9. USDA CERTIFICATE OF INDEPENDENT PRICE DETERMINATON: This form (Attachment D) must be signed and returned with your proposal. Failure to return this form will result in your proposal not being accepted.
- 10. **NON-COLLUSION AFFIDAVIT:** This form (Attachment E) must be signed and returned with your proposal. Failure to return this form will result in your proposal not being accepted.
- 11. **SCHOOL ADDRESS LIST**: This document (Attachment F) provides the location and contacts for the school cafeterias.
- 12. A one-page summary of each Responder's recall policy and procedures.
- 13. **ESCAMBIA SCHOOL DISTRICT PUBLIC RECORDS ADDENDUM:** This form (Attachment G) must be initialed and returned with your proposal. Failure to return this form will result in your proposal not being accepted.
- 14. ECSD POLICY FOR DATA ANALYSIS/MINING, SHARING, TRANSFER AND DESTRUCTION: (Attachment H)
- 15. A sample copy of printed electronic delivery ticket, if applicable.
- B. JESSICA LUNSFORD ACT: Vendor will comply with all requirements of Sections 1012.32 and 1012.465, Florida Statutes, by certifying that the vendor and all of its employees who provide services under this contract have completed the background screening required by the referenced statutes and meet the standards established by the statutes. This certification will be provided to the school in advance of the vendor providing any services on campus while students are present. The vendor will bear the cost of acquiring the background screening required by Section 1012.32, F.S., and any fee imposed by the Florida Department of Law Enforcement to maintain the fingerprints provided with respect to vendor and its employees. The vendor will follow the procedures for obtaining employee background screening as outlined on the Escambia County School District Website: http://ecsd-fl.schoolloop.com. Vendor will provide school a list of its employees who have completed background screening as required by the referenced statutes and meet the statutory requirements. Vendor will update these lists in the event that any employee listed fails to meet the statutory standards or new employees who have completed the background check and meet standards are added. The parties agree that in the event that vendor fails to perform any of the duties described in this paragraph, this will constitute a material breach of the contract entitling school to terminate immediately with no further responsibility to make payment or perform any other duties under this contract. Vendor agrees to indemnify and hold harmless school, its officers and employees from any liability in the form of physical injury, death, or property damage resulting from vendor's failure to comply with the requirements of this paragraph or Sections 1012.32 and 1012.465, Florida Statutes.
- C. **DEFAULT:** The awarded Responder shall inform the School Food Services Department of any problems or delays in providing the awarded item(s) as required. The District shall consider excessive product cost, repetitive non-deliveries, late deliveries, and/or deliveries of products which are either of poor condition or not meeting specifications, to be in default of the contract, and my result in termination of the contract.
- D. **INSPECTIONS:** All products delivered shall conform in all respects to applicable standards promulgated under the Federal Food, Drug and Cosmetic Act, and the Meat Inspection Act and the Poultry Products Inspection in effect at the time of delivery. No product that contains any artificial coloring agent, such as #2 red dye, is to be offered on this RFP.

- E. **GRADES FOR FOOD:** Grades for foodstuffs are based on standards established by the U.S. Department of Agriculture, Agricultural Marketing Service and items supplied must be of grade indicated for the item.
- F. FACILITIES INSPECTIONS: The District reserves the right, prior to award of any contract and throughout the contract period, to inspect the prospective awardee's facilities and place of business to determine that the awarded vendor has a regular, bona fide establishment that does not presently have an on-going concern that will continue during the awarded contract period(s). Areas of evaluation by District representatives may include, but are not limited to warehouse facilities, total cubic feet and condition of warehouse, and delivery fleet capacity in terms of number and size of trucks to properly transport and protect frozen products. Responders shall submit their most recent Sanitation Audit Scores with their proposal.
- G. **DESIGNATED CONTACT:** Awarded Responder(s) shall appoint a person to act as a primary point of contact for the School Food Services Office. This person and their back-up shall be readily available during normal work hours by phone or in person, and shall be knowledgeable of the terms and conditions of this agreement.
- H. **INCOMPLETE RFP INFORMATION:** Failure to submit complete information regarding an item will prevent any consideration of your proposal for that item. We must have MDW and/or yield when requested.
- I. IRRADIATION PROCESS: Do not offer any food items preserved by the use of an irradiation process.
- J. **MINIMUMS:** The Responder may include a statement regarding minimum order quantities or value affecting final order processing.
- K. **RFP QUANTITIES**: **Quantities indicated in this RFP are estimates based on prior year usage.** Actual purchases may vary from item to item and the School District cannot guarantee that items will be purchased exactly as indicated.
- L. **TERM OF AGREEMENT:** All prices, terms, and conditions of this purchasing agreement will be fixed for the initial term of August 1, 2018 through April 30, 2019. Two (2) one-year renewal options are available upon mutual consent of both parties, with the first renewal period beginning May 1, 2019 and ending April 30, 2020. All pricing proposed herein shall be fixed through the initial term. For successive renewal year(s), Responder may request an increase equal to the allowable increase in the School Food Lunch Reimbursement program using the index in effect at the time of the request. The request to increase prices must be submitted in writing with supporting supplier invoices and any other documentation supporting the Responder's cost increase to the Purchasing Department ninety (90) calendar days prior to May 1 of each renewal year. The request will be subject to review, negotiation, and/or award termination. The approval of any price increase will be determined solely by the District. If the District agrees to the price increase, the contract may be renewed for an additional one (1) year period at the new pricing level with all other terms and conditions remaining unchanged.
- M. **EX PARTE COMMUNICATIONS:** Ex parte communication, whether verbal or written, by any potential Responders or representative of any potential Responders to this proposal with District personnel involved with or related to this proposal, other than as expressly designated in this document, is strictly prohibited. Violation of this restriction may result in the rejection/disqualification of the Responder's offer.
- N. **APPLICABLE LAWS:** All products and deliveries must meet the State Board of Health and Escambia County Health Department specifications and standards, and must comply with Federal

Statutes Executive Orders and the requirements of 7CFR 21, 7 CFR 3016.36 and 7 CFR 3016.60 (b) and (c).

- O. **EXAMINATION OF RECORDS:** The Responder agrees that the District, the Comptroller General of the United States of America and/or the Inspector General of the Federal Sponsoring Agency, and the Auditor General of the State of Florida or their duly authorized representatives shall have access to, and the right to examine, any directly pertinent books, papers, and records of the Responder involving transactions related to this agreement until the expiration of five (5) years after final payment under this agreement or such longer period as required by law.
- P. BUY AMERICAN PROVISION: As a participation sponsor in the USDA's National School Lunch and School Breakfast Programs, the School District of Escambia County, Florida and School Food Services Department must adhere to the "Buy American" 7 CFR Part 210.21(d) provision of the Child Nutrition Reauthorization Act. The provision requires school districts to purchase, to the maximum extent practicable, domestic food products that are produced in the United States. The Legislature defines "domestic commodity or products" as one that is produced in the United States and is processed in the United States substantially using agriculture commodities that are produced in the United States. Substantially means that a minimum of 51% of the final processed food comes from American produced products. Therefore, items normally not produced in the United States commercially, the vendor should make every effort to purchase domestic products.
- Q. ADDITIONAL FEDERAL REQUIREMENTS: While not provided as separate certifications in this proposal, by signing this proposal, the signatory attests to the applicable certification provisions listed below:
  - 1.   - 3. Certification Regarding Lobbying pursuant to 31 U.S.C. 1352 (Appendix A: 7 C.F.R. Part 3018).
  - 4. Disclosure of Lobbying Activities pursuant to 31 U.S.C. 1352 (Appendix A: 7 C.F.R. Part 3018).
  - 5. Energy Policy and Conservation Act (Pub. L. 94–163, 89 Stat. 871).
  - 6. Contract Work Hours and Safety Standards Act (29 C.F.R. Part 5).
  - 7. Executive Order 11246, entitled Equal Employment Opportunity, as amended by Executive Order 11375 and Department of Labor Regulation (41 C.F.R. Chapter 60).

All announcements and other materials publicizing this program must include statements as to the amount and proportion of federal funding involved.
  - 11. Right to Inventions Made Under a Contract or Agreement (37 CFR 401.2(a).

- 12. Procurement of Recovered Materials (§200.322), EPA (40 CFR Part 247).
- 13. Breach of Contract {2 CFR Appendix II to Part 200(b)}.
- R. INDEMNIFICATION: The School Board of Escambia County, Florida agrees to indemnify the awarded Responder(s) to the extent and only to the extent of the limits set forth in 768.28(5), Fla. Stat. and then only for the negligent or wrongful act or omission of any officer or employee acting within the scope of the officer's/employee's office or employment under circumstances in which the state or such agency or subdivision, if a private person, would be liable to the claimant. Further, except as specifically provided herein, the School Board does not waive any defense of sovereign immunity. It is further understood and agreed by the parties to this agreement that no officer or employee may be held personally liable except as provided by 768.28(9), Florida Statute.
- S. RESPONDER QUALIFICATIONS: Proposals will only be considered from commercial distributors who meet the qualifications listed below. Responders must have adequate organization, facilities, equipment and personnel to ensure prompt and efficient service. The District reserves the right, before recommending any award, to inspect the facilities and organization or to take any other action necessary to determine the Responder's ability to perform in accordance with the RFP's specifications, terms and conditions. The District will determine whether the evidence of ability to perform is satisfactory and will make an award only when such evidence is deemed satisfactory and reserves the right to reject RFPs where evidence submitted, or investigation, and evaluation indicates an inability of the Responder to perform. The awarded Responder must be able to provide and deliver a minimum of 85% of the products listed in Section VII Pricing and Specifications. Items marked in bold type and marked with an asterisk (\*) must have a price offer for your proposal to be considered. The District will have sole discretion to determine whether a Responder meets the qualifications stated below and the requirements of Section III, Special Conditions, Paragraph A Documentation and Required Enclosures.
  - 1. Responder must be currently engaged in distributing commercial foods to the food service and/or retail trades.
  - 2. Responder must have or have access to utilize refrigerated warehouse facilities capable of holding temperatures at zero (0) ° F.
  - 3. Responder must have or have access to a fleet of mechanically refrigerated trucks or truck compartments capable of holding air temperatures at zero (0) ° F while on the delivery routes.
  - 4. Responders shall provide documentation of applicable licenses, certifications, and/or commercial experience. The Escambia County School District reserves the right to request updated information or re-verification of Responder's license and documentation at any time during the contract period.
- III. AWARD CRITERIA: The award will be based on Inventory/Product Distribution Capability, Service, Value Added Service, Delivery Capability, Experience/References, and Price. Each response to the criteria below shall be reviewed by an evaluation committee and awarded points. The best response will receive the highest number of points for that response with all other responses receiving an amount less than the maximum. A Responder must be able to provide and deliver a minimum of 85% of the all the products listed in Section VII Pricing and Specifications. Items marked in bold type and marked with an asterisk (\*) must have a price offer for your proposal to be considered. The Responder who receive the highest points overall will be recommended for the RFP award.

- 1. **INVENTORY/PRODUCT DISTRIBUTION CAPABILITY:** (20 pts.) The Responder must be capable of providing and maintaining sufficient frozen food inventory to service school locations as required by the District. The Responder will provide documentation to demonstrate on-hand inventory and/or manufacturer/distributor partnerships. Past performance may also be considered.
- 2. **SERVICE:** (15 pts.) The Responder that receives this RFP award shall treat each of the ECSD schools/Food Service Management Office as one of their best customers. Therefore, any treatment and/or customer service policy given to other essential accounts shall also be given to the customers covered under this solicitation. All products shall be delivered to individual delivery points (unless otherwise noted). No substitutions will be accepted unless authorized by the District's Food Services Management Office. The Responder shall provide documentation regarding your customer service policies/procedures and the name(s) and years of experience of the representative(s) who will serve the ECSD account. Past performance may also be considered.
- 3. VALUE ADDED SERVICE: (10 pts.) Indicate what type of Value Added Services (i.e. any service that will provide additional knowledge and assistance from the vendor to the District) that will help increase customer satisfaction. This should include, but is not limited to, information regarding your order entry technical capabilities, marketing/customer service abilities, turnaround time, and resolution of delivery/ordering errors. Clearly describe your ordering software system, return and recall procedures, delivery/ordering errors procedures, and frequency of customer support/service visits you plan to provide. This is to be submitted with your proposal.
- 4. DELIVERY CAPABILITY: (10 pts.) The Responder and/or his delivering carrier shall utilize properly insulated, mechanically cooled, thermostatically controlled equipment. The proper temperature for frozen food items is zero (0) F degree. <u>All frozen food items must arrive in a hard, frozen state.</u> Past performance may also be considered. Provide a list of the current delivery vehicles which will service the ECSD to include the model, year, and load capacity.
- 5. **EXPERIENCE AND REFERENCES:** (5 pts.) The Responder shall provide a brief description of company background to include qualifications listed in Paragraph S on page 11, staffing personnel who will serve the District, how many accounts similar in size to the District are serviced and provide references on Form Number P002 Attachment C.
- 6. **TOTAL PRICE.** (40 pts.) The Responder with the overall lowest prices will receive the maximum points. <u>The items in bold type and marked with an asterisk (\*) must have a price offer for your proposal to be considered.</u>

#### V. SCOPE OF WORK OR SERVICES

The successful Responder shall furnish and deliver frozen food products directly to the school cafeterias throughout the Escambia County School District. All food products will be purchased in compliance with the Buy American Act. Deliveries will be made once a week or as requested by the cafeteria manager.

A. **ORDERING SYSTEM:** The District currently utilizes Horizon and Skyward Financial softwares for food procurement. The Responder shall provide responses and any documentation needed for evaluation purposes for the following questions/statements:

• Can your ordering/distributing system interface with Horizon and Skyward softwares? If yes, please explain how it will operate?

- Does the Responder's system allow for web-based access or Business-2-Business in order to:
  - 1. Allow individual site order submissions?
  - 2. Provide an on-line catalog or order guide of products specific to Horizon or Skyward software that is available for download and with on-line search capabilities?
  - 3. Restrict users who enter orders to only have access to District approved items?
  - 4. Allow the ability to alter orders, add items, or delete items from order?
- What is the minimum order lead time for orders placed by the ECSD?
- Does access to the Responder's software allow for the District to review out of stock items and the time frame of arrival and delivery of product?
- Explain what technical assistance is available when questions or issues arise.
- What training is provided for District personnel in the use of the Responder's ordering software? Is training provided at no cost to the District?
- Responder shall comply with District's requirements for data analysis/mining, sharing, transfer, and destruction. Refer to Attachment H.
- The District shall not be responsible for order entry errors resulting from technical/equipment malfunctions attributed to the Responder's software.

#### B. CUSTOMER SERVICE:

- Responder must provide one (1) dedicated customer service representative as a liaison to assist District personnel with on-line orders, delivery, credit requests, and/or product concerns.
- Responder must be able to provide account service to other District affiliation departments and governmental agencies for purchasing commercial food products at the contracted pricing.
- Responder must provide usage reports by specific manufacturer, specific time frame, and/or by school as requested by the District.
- C. **PRODUCT QUALITY:** All products purchased shall be in compliance with the Buy American Act. <u>All frozen foods shall be delivered in a freezer truck in a hard, frozen state at zero (0) degrees</u> <u>Fahrenheit (F).</u>
- D. PRODUCT AVAILABILITY: If, for any reason item(s) ordered by a cafeteria cannot be delivered when requested, because of unavailability, the Food Services Office should be notified in writing at least one (1) day prior to scheduled delivery date and the vendor should offer substitution options. All District cafeterias will have up to two (2) days prior to delivery to add and/or cancel items.
- E. **REJECTION PROCEDURES:** The School District and Cafeteria staff have the right to reject any product that does not meet the proper standards as detailed in this RFP. Failure by the cafeteria staff to promptly inspect or accept supplies shall not relieve the vendor from responsibility, nor impose liability on the customer for nonconforming food product.
- F. **PRODUCT RECEIVED IN CONDITION THAT WOULD RENDER IT UNFIT FOR HUMAN CONSUMPTION:** All products delivered shall have been processed and packed in accordance with good commercial practices. Any food product offered for delivery that has, in the expert opinion of the Food Services Staff, the local Health Department, and USDA Health Inspector, been for any reason

rendered unfit for human consumption shall be refused and returned to the shipper at the shipper's expense or otherwise disposed of at the direction and expense of said shipper. Any frozen product that has thawed and/or shows signs of thawing and re-freezing would fall in the above category.

- G. VENDOR PERFORMANCE: Vendor must maintain an acceptable level of performance throughout the term of the contract and is required to provide frozen food products in compliance with current USDA and ECSD Standards. Supplies transported in vehicles that are not sanitary and equipped to maintain prescribed temperatures will be rejected. The District reserves the right to inspect vendor vehicles and all operating plants and facilities. Whether the product meets current ECSD standards will be determined by the Food Services Office. Any vendor who is not able to perform the requirements of this agreement, or whose prices rise above an acceptable, competitive market range, or generate significant customer dissatisfaction, will be subject to award termination.
- H. ACT OF GOD: Vendor shall have a plan for distribution of unused product in the event of an "Act of God," such as hurricane, etc., where the vendor would be expected to move as much ordered product as possible to its other customers in the event a school should have to be closed without notice. In the event the vendor's facilities are affected by an Act of God (i.e. hurricane, etc.) and the vendor cannot deliver when scheduled, vendor should notify the School Food Services Office at their first opportunity so the District can make other arrangements for the affected period.
- QUALITY CONTROL/RECALL: Quality Control Reports are an internal tool used by school cafeteria managers to communicate to the School Food Services Office regarding service, quality of product, contamination, and so forth. Quality Control Reports addressing contamination or any other urgent issues must be responded to immediately by the vendor, in writing. All other quality control reports will be forwarded to the vendor and the vendor must respond, in writing, within seven (7) calendar days of notification.
- J. FOOD SAFETY AND RECALLS: Ensuring the safety of the food supply is critical to ECSD. Manufacturers, distributors, and importers are expected to comply with all federal, state and local laws and regulations and are liable if they do not. Recalls are an effective method of removing or correcting consumer products that are in violation of laws administered by the Food and Drug Administration. The potential bidder shall have a process in place to effectively respond to a food recall which should include the following objectives:
  - 1. Provide accurate and timely communication to ECSD regarding a food recall.
  - 2. Ensure that unsafe products are removed from school sites in an expedient, effective and efficient manner.
  - 3. Streamline the process for reimbursement for recalled product.
  - 4. A one page summary of each Responder's recall policy and procedures are to be submitted with this proposal.
- K. DELIVERY: Deliveries shall be made once a week between the preferred time of 6:15 a.m. through 10:00 a.m. providing that the cafeteria staff is on duty. Deliveries shall not be no later than 2:00 p.m. All delivery changes must be submitted in writing via e-mail to the Food Services Management Office and Purchasing Department. This document will become part of the contract agreement. Any future change in delivery frequency must also go through the same process. Access to District campuses will be Monday through Friday, except school holidays, partial or unscheduled closing days. When school holidays fall on a scheduled delivery day, deliveries shall be made on the next school day or the prior school day. This does not preclude the vendor or the cafeteria manager from making periodic adjustment requests for the convenience of either party providing that both parties are in agreement. Such changes should be rare and reasonable in nature. The vendor shall never leave food products unattended on a loading dock under any circumstances. All food products must be delivered during a time when the cafeteria staff is present. Food products

cannot be left with custodial, security, or any other non-cafeteria school staff. Any request for change in delivery service or receiving personnel must be submitted in writing to the Escambia County Food Services Office.

- L. **DELIVERY ACCURACY AND PRODUCT QUALITY:** The Awarded Responder is expected to make deliveries with a minimum of errors. Unapproved deliveries made outside established delivery time frames shall not be tolerated and is considered to be reason for contract termination.
- M. ITEM SUBSTITUTION: If the awarded Responder is <u>temporarily out-of-stock</u> of a particular item, they must deliver an equal or superior product at an equal or lower price, <u>with prior approval</u>, from the School Food Services Office. All outages and substitutions must be submitted to the School Food Services Department a minimum of twenty-four (24) hours prior to delivery. Excessive occurrences of out-of-stock items may be cause for contract cancellation. The Responder shall notify the District in writing of any ingredient, nutritional, or preparation process changes within ten (10) days of the Responder receiving information from the manufacturer.
- N. DISCONTINUED ITEMS: In the event that the producer/supplier replaces the specified products with a new product, the Responder will notify the Purchasing Agent indicated on page one (1) in writing no later than seventy-two (72) hours after receiving notification from the producer/supplier. The Responder shall apprise the District of any product replacement options at the proposal price, and/or any cost reduction available for the specified product(s). The District reserves the right to authorize or reject such product replacement and/or cost reduction on any specified product(s).
- O. **OBSOLETE ITEMS:** If a product is no longer needed, the District reserves the right to remove items from the contract with a thirty (30) day written notice.
- VI. INVOICES, STATEMENTS AND PAYMENTS. Invoices for the purchase of food and nonfood supplies made for schools are to be paid by the Food Services Central Accounting Office. <u>All invoices must be itemized to show the unit and extended price. Invoices must have an invoice number and date. Invoice numbers shall not be duplicated for any reason. All mailed or electronic invoices must be readable and <u>clear.</u> In order to facilitate the handling of these invoices, all vendors must adhere to the following instructions:</u>
  - A. **CAFETERIA CODE NUMBER:** Each Invoice shall list the appropriate School Cafeteria Cost Center Code on it. A list of these code numbers is included in this document per Attachment F.
  - B. **DELIVERY DATES/PERIOD:** Each invoice shall indicate the delivery dates to which the invoice pertains.
  - C. ITEM DESCRIPTIONS: All items on delivery tickets must be billed according to the descriptions of item offered in this RFP. Unit prices for items shall be recorded in the unit of measure presented in Section VII – Specifications and Pricing. All invoices shall be accurately extended.
  - D. **DELIVERY TICKETS/INVOICES/CREDIT MEMOS:** All invoices and credit memos must be submitted in triplicate; and all three (3) copies must be signed by the cafeteria manager or their authorized representative. The three (3) copies will be distributed as follows and contain the following information:
    - 1. Two (2) copies (original and one (1) carbon) left with manager at the time of delivery.
    - 2. One (1) copy returned to vendor.
    - 3. A list of school cafeterias with addresses, contact names, and phone numbers for each school is provided on Attachment F.

- 4. <u>If electronic delivery tickets are used by the Responder, a sample copy of the printed ticket must</u> <u>be submitted with your proposal for approval by the ECSD.</u> Delivery tickets must be itemized and readable.
- 5. The Responder shall generate weekly itemized invoice statements for each school cafeteria. Each invoice statement number must be different. The cafeteria managers shall forward on a weekly basis signed delivery tickets directly to the School Food Services Central Accounting Office. <u>All invoices must be in exact agreement with the delivery tickets left with the cafeteria manager.</u>
  - a. All cancellations or merchandise returns must be recorded by the driver on all three (3) copies of the invoices or "pickup tickets" and these copies should be distributed as follows:
    - i. Two (2) copies left with manager at time of pickup.
    - ii. One (1) copy returned to vendor.
  - b. All credit memorandums necessitated by non-delivery of centrally purchased items will be deleted from the total payment for that period, listed separately and supported by descriptive information.
- 6. Do not mail information to individual schools. Except for the school's two (2) copies of the invoices, all other information shall be mailed to the following:

#### ESCAMBIA SCHOOL DISTRICT PUBLIC RECORDS ADDENDUM

CONTRACTOR'S RESPONSIBILITY FOR COMPLIANCE WITH CHAPTER 119, FLORIDA STATUTES. Pursuant to Section 119.0701, F.S., CONTRACTOR agrees to comply with all public records laws, specifically to:

A. Keep and maintain public records required by the School Board to perform the service.

1. The timeframes and classifications for records retention requirements must be in accordance with the General Records Schedule GS1-SL for State and Local Government Agencies and GS7 for Public Schools. (See <a href="http://dos.myflorida.com/library-archives/records-management/general-records-schedules">http://dos.myflorida.com/library-archives/records-management/general-records-schedules</a>)

2. Records include all documents, papers, letters, maps, books, tapes, photographs, films, sound recordings, data processing software, or other material, regardless of the physical form, characteristics, or means of transmission, made or received pursuant to law or ordinance or in connection with the transaction of official business with the School Board. Contractor's records under this Agreement include but are not limited to supplier/subcontractor invoices and contracts, project documents, meeting notes, emails and all other documentation generated during this Agreement.

B. Upon request from the School Board's custodian of public records, provide the School Board with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided for by law. If a Contractor does not comply with the School Board's request for records, School Board shall enforce the provisions in accordance with the contract.

C. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following completion of the contract if the Contractor does not transfer the records to School Board.

D. Upon completion of the contract, transfer, at no cost, to the School Board all public records in possession of the Contractor or keep and maintain public records required by the School Board to perform the service. If the Contractor transfers all public records to the School Board upon completion of the contract, the Contractor shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If the Contractor keeps and maintains public records upon the completion of the contract, the Contractor shall meet all applicable requirements for retaining public records. All records kept electronically must be provided to the School Board, upon request from the School Board's custodian of public records, in a format that is compatible with the information technology systems of the SCHOOL BOARD.

# Notification of Amendments to Policies

4.1. Contractor shall provide prior written notice to District of any material changes to its terms of service, terms and conditions of use, license agreement and/or privacy policies that would alter the way data, designated as confidential or not, is collected, stored, handled, disseminated or distributed, at least thirty (30) days prior to the implementation of any such change. District must approve changes in writing, which will not be unreasonably withheld.

4.2. It is understood and agreed that only the terms and conditions set forth in the Agreement, as duly executed between the District and Contractor, will be binding, regardless of whether a user "accepts" the terms and conditions presented upon logging in, an email notification is generated, or a revision is posted to the Contractor's website.

## **Data Analysis and Mining**

Contractor is prohibited from analyzing or mining data for any purpose other than delivering the Service to District under this Agreement, or improving the Service for District. Analysis and mining of data to support marketing, advertising or other commercial ventures, whether by Contractor or a third party, are prohibited.

## **Data Sharing and Re-Disclosure**

District understands that Contractor may rely on one (1) or more sub-contractors to provide the Service under this Agreement, which may have access to data. At all times, the Contractor warrants and agrees to be held liable and fiscally responsible for the deliberate and/or unintentional acts and/or omissions of sub-contractors utilized in the performance of these Services who fail to adhere to the requirements for data confidentiality and security contained in the executed Agreement between the District and Contractor.

## **Data Transfer and Destruction**

Upon notice from District, Contractor will ensure that:

(a) A complete, readable and usable copy of all data in Contractor's possession will be delivered to District within sixty (60) days following notice from District, and;

(b) This copy of all data will be provided in a standard format with standard delimiters and a matching data dictionary, mutually agreeable and sufficient to enable efficient transfer of the data to a new system, and;

(c) This copy must include all data which may have been re-disclosed to or held by subcontractors or agents of Contractor, and;

(d) Following notice of acceptance of this copy of all data by District, Contractor will permanently destroy all copies of data held by Contractor or re-disclosed by Contractor, e.g. to Contractor's agents, sub-contractors or business partners.

(e) Within ninety (90) days of notice, Contractor will deliver a written confirmation to District certifying that the permanent destruction of all data held by Contractor and Contractor's sub-contractors, agents and business partners has been completed.
