Band uniforms to outfit the Tate High School marching band: three hundred (300) bibber trousers, three hundred (300) marching coats, three hundred (300) Aussie hats, and one (1) uniform management software program. The total estimated price is \$97,764.00.

Uniform samples were examined by an Evaluation Committee consisting of three (3) Tate High School staff members (the Band Director, the Assistant Band Director and the band booster manager.), and one (1) seamstress. One (1) Purchasing Agent and one (1) District Staff member attended the evaluation, but were not voting members of the committee. The vendors and uniforms were rated by: Responsiveness to RFP (Up to 10 Points), Cost of the Garment (Up to 35 Points), Quality of the Garment (Up to 35 Points), References (Up to 10 Points), and Delivery Time (Up to 10 Points). Award to the bidder ranked highest by the Evaluation Committee.
