The following information contained in the original RFP has been added, deleted, or replaced:

1. **Section IV. A. 6. (Page 10) is deleted in its entirety.**
2. **The following Section IV. I. is added after Section IV. H. on Page 11.**
  - I. **LOCATION-SPECIFIC LANDSCAPING SERVICES:** Responder shall complete location-specific landscaping services (e.g. spreading of mulch, pine straw, or other similar materials) as-needed and as assigned by the Maintenance Department. The District shall supply all mulch, pine straw, etc. for any location-specific landscaping needs on a case by case basis. Responder shall spread mulch and/or pine straw in an even and uniform layer upon areas designated by the Maintenance Department or designee. Responder shall obtain written approval from the Maintenance Department or designee regarding the thickness of mulch or pine straw layers prior to spreading. Responder shall provide an hourly labor rate for location-specific landscaping services in Section III of Attachment A on Page 18. No Location-Specific Landscaping Services shall be performed unless Responder receives a written request from the Maintenance Department or designee.
3. **The following Section III is added to Attachment A after Section II on Page 18. The requested hourly labor rate must be provided in this Amendment I, which must be included with Responder's Proposal.**
