DESCRIPTION OF PURCHASE:

An agreement (renewable annually for a period of up to five (5) years) to provide school cafeterias with a list of approved fast food vendors offering specific products. This program serves as one of the District's efforts to follow the National School Lunch Program's recommendation to offer more variety and options in a la carte meals in secondary schools. Products were evaluated and deemed acceptable or unacceptable by means of a student taste test. Decisions to utilize this resource rests with Food Services and the cafeteria management of each school. No sales are guaranteed to the vendor. Cafeterias have the option to discontinue delivery of any product or vendor providing this service to their school if: 1) the use of this product does not prove beneficial to that particular school's operation; 2) the student interest decreases; or 3) the product quality decreases. Each school has the option to try new products from approved vendors in order to stimulate student interest and provide menu variety. Additional products and vendors may be approved during the course of this agreement. If additional products and vendors are approved, an amendment will be taken to the School Board requesting approval to add the new vendors and/or products.
